Thank you to our dedicated and professional members! Within two weeks of our return from New York, a debriefing and strategy meeting was quickly arranged, with the support of UN Women in Geneva. We looked at the agreed conclusions, already planning how to improve the working methods for next year, and get an earlier start. Recommendations gleaned from the debates, the Geneva Consultation Day and our Ambassadors Breakfast Briefing have been assembled as a guide for our followup advocacy, and for members' organizations local implementation. Another important outcome is how the issues of this year's CSW have influenced collaboration with ITU, UN Women, UNECE and UNICEF Geneva, and some of our government missions, which will be carried over to our work at the Human Rights Council, Beijing +30, future Ambassador's Briefings, and our 50th Anniversary commemorations. Make Mothers Matter

Make Mothers Matter has actively participated in the 61st UN Commission on Social Development, which took place in February 2023 in New York, and focused on decent work. In addition to our written Statement on mothers and decent work, an oral intervention on unpaid care work, we organized a virtual side-event, 'Leave no single mother behind', which presented concrete solutions from grassroots organizations across the world, to support and empower single mothers to access decent work.

Soroptimist International

Despite the international resolutions and declarations that promise the advancement of gender equality, the world is currently witnessing an unprecedented paradox. International commitments to women and girls are failing and are actively being reversed. An alarming number of women and girls are experiencing outright denial of their basic human rights; their visions ignored, their voices suppressed, or even brutally silenced. A new position paper on the critical importance of 'Defending Women's Rights against Global Suppression of their Voices' was created.

The 5th Human Rights Internship Program culminated on Friday, 28 April with a webinar led by the interns, representing three regions on, "UK and EU National Policies on Human Rights in Developing Countries". After close participation in the Expert Mechanism on the Right to Development (EMRTD) sessions over the last two years in Geneva by WFWPI and NGO CSW Geneva, Srruthi Lehka, Geneva WFWPI representative, was invited as a speaker when the mechanism held its session at the UN in New York in April.

Gender-Related Killings of Women and Girls (femicide/feminicide)

Violence against women and girls is the most pervasive human rights violation rooted in gender inequality and discrimination, unequal power relations, and harmful social norms. The gender-related killing of women and girls is the most brutal and extreme manifestation of such violence. UNODC and UN Women have joined forces to produce this research paper on the global estimates of gender-related killings of women and girls in the private sphere in 2021. Changes of the Swiss Corporate law + Anti-Money laundering Act Reform

CAGI recently invited foundations and NGOs to a presentation on the impact of recent changes in the Swiss law, as from January 1st, 2023. Two changes might impact NGOs:

A foundation or association must register in the Register of Commerce if the following 3 cumulative conditions are reunited:

- 1. Collection or distribution of funds for charitable, religious, cultural, educational or social purposes
- 2. Exercise of this activity as a primary activity
- 3. Raising or distributing funds abroad

Cases of exception (cumulative)

- 1. During the last two years, neither the annual amount of funds collected nor the amount of funds distributed exceeded CHF 100'000.-
- 2. The funds are distributed by a financial intermediary within the meaning of the AMLA, e.g. by a bank within the meaning of article 2 para. 2 let. a AMLA.
- 3. At least one representative of the association is domiciled in Switzerland.

Use of electronic media for the preparation and conduct of General Assembly meetings and Board meetings Art. 701e CO Hybrid meeting:

- Decision of the supreme governing body
- Compliance with the conditions of Art. 701e CO
 - o the identity of the participants is established;
 - the oral contributions at the general meeting are directly transmitted;
 - each participant can table motions and participate in the debate;
 - o the result of the vote cannot be falsified;
 - o data protection to be ensured
